## **Fort Hood WIC Clinic Relocation**

Temple, Texas – The Bell County Public Health District Women, Infants and Children (WIC) office on Fort Hood is temporarily relocating to a new site.

Bell County Public Health District WIC Program is temporarily relocating its Fort Hood clinic from on post to downtown Killeen. The Fort Hood clinic is moving from Building 289, Battalion Avenue on post to 111 Santa Fe Plaza in downtown Killeen. The Fort Hood WIC clinic will share space with the Killeen WIC clinic until construction is complete on its new location at the old Darnall hospital.

This location change occurred late June and will continue until November 2017. Due to the unexpected temporary move, Fort Hood WIC staff have been sending letters out and contacting their clients to inform them of their new location. The Killeen location is less than 3 miles from the former Fort Hood location. WIC parents can still expect to receive the same great services and options at the Killeen location.

During this temporary relocation, the Fort Hood WIC clinic will change their hours starting September 1 in order to remain open one Saturday a month. Normal business hours are Monday through Thursday 7 am to 5:30 pm and closed 12-12:30 pm daily. Beginning September 1, the Fort Hood clinic will be open the third Saturday of each month from 8 am to 12 pm (closed at 1 pm the Thursday prior).
